The third module of the pack is Orbit Intelligence which is a powerful search engine with features like searching global patents, value added content summary of invention, prior art and FTO resources.

NOTES ON FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST MARCH, 2020

Note -1

INFORMATION ABOUT THE SOCIETY:

I-TIC Foundation IIT Hyderabad (i-TICH) was incorporated on 31st October, 2015 under Andhra Pradesh Societies Registration Act, 2001 with a primary objective to promote innovation and entrepreneurship by converting & translating technology ideas & innovations in various disciplines of science and engineering into products, processes & services for commercial exploitation and benefit of the society.

a. SYSTEM OF ACCOUNTING:

The Society follows the mercantile system of accounting and recognizes Income & Expenditure on accrual basis during the year. The accounts have been prepared in accordance with the generally accepted accounting principles.

b. FIXED ASSETS:

Fixed Assets are valued at cost of acquisition less depreciation.

c. DEPRECIATION:

Depreciation has been provided by the firm as per the rates prescribed under the Income Tax rules on written down valued method

d. PROVISION FOR INCOME TAX:

No provision for Income Tax has been made for the year.

e. CORPUS FUND

Fund for Incubation Activities (CSR Donation Received with Specific Directions): These donations are received from corporate against CSR with specific directions to expend it as per the CSR agreement with different corporate.

f. <u>RESERVES & SURPLUS</u> f.1 Capital Reserves

i) For Investment in shares of Company: This reserve is created for Shares received from Incubatees as per the Incubation Agreement without any consideration.

f.2. Revenue Reserves

i) General Grants & Donations from Government Authorities for Revenue Expenditure: These grants are received from different government authorities to utilize it for General Administrative expenses

g. UTILISATIONS OF GOVERNMENT GRANTS, CSR FUNDS & OTHER DONATIONS RECEIVED

Grants related to corpus fund are to be utilized for purchase of assets, is presented in the balance sheet by showing the grant as a deduction from the gross value of the assets concerned in arriving at their book value. Where the grant related to a specific fixed asset equals the whole, or virtually the whole, of the cost of the asset is shown in the balance sheet at a nominal value. In this Financial Year society has utilized ₹ 87,13,477/- for purchase of 3D printer (asset) which is deducted from Corpus Funds and shown in Balance sheet at Rs.1/- which is in conformity with Accounting Standard-12 issued by The Institute of Chartered Accountants of India.

Grants from Various Corporates & Government Authorities which are received with specific directions for utilization are presented in the balance sheet by showing the grant as a corpus donation and corresponding investment in asset is either shown as Investment in Term Deposits for unutilized amount & as a Seed Funding to incubatees for amount already utilized and not as a deduction from the gross value of the grant concerned in arriving at their book value. And where the grant is received for providing funding to the incubatee, the amount provided to the Incubatee will be shown as deduction from the grant received once the incubatee is graduated from the incubation center and the corresponding balance in Seeding funding to Incubatees will be reduced.

h. INVESTMENTS

Investments which are readily realizable and intended to be held for not more than 12 months are classified as current investments. All other investments are classified as Non-Current Investments. Non - Current Investments are stated at cost of acquisition and related expenses. Provision for Diminution, if any, in the value of such investments is made to recognize a decline, other than of a temporary nature.

Current Investments are stated at cost of acquisition including incidental/ related expenses or at quoted/fair value as at **31st March**, **2020** whichever is less and the resultant decline, if any, is charged to revenue

Seed Funding to Incubatees shown under the head "Investments", is utilized out of CSR funds under the head Fund for Incubation Activities & is a contra account against the Funds for Incubation Activities & Grants From government authorities which will be deducted from the Capital Reserve once the incubate graduates from the incubation center.

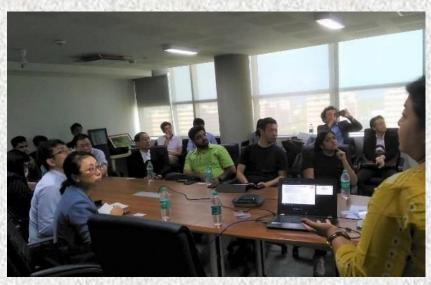
